On The 6th day of December, 2017 at 7:00 p.m. for electors of the Town to consider exceeding the allowable tax levy limit, and to approve the total town levy for this year.

The actions will be decided by a majority vote of the Town of Neshkoro electors (Eligible Voters) in attendance.

For the following purposes:

1. To consider the adoption of a resolution by the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under s. 66.0602 of Wis. Statutes, specifically a proposed tax levy which would exceed the allowable tax levy for 2017 by 31.65 percent which would be A dollar increase of \$40,000
2. To approve the 2017 total tax levy to be collected in 2018 pursuant to s. 60.10(1)(a) of Wis. Statutes.

Resolution of Town Board to Propose Exceeding the Levy Limits

Whereas, the State of Wisconsin has adopted levy limits on town, village, city and county levies
For 2017 and thereafter under s. 66.0602 of Wis. Statutes:

Whereas, s. 66.0602 of Wis. Statutes limits the allowable local levy for 2017 to a percentage increase
of no more than the greater of (a) 0% of the 2016 payable 2017 adjusted actual levy as calculated under
the state's levy limit law or (b) a percentage equal to the percent change in equalized value due to net
new construction: which for the Town of Neshkoro is .327 percent:

Whereas, the Town Board of Neshkoro, Marquette County believes that for the 2017 tax levy
(collected in 2018) it is in the town's best interest to exceed the state levy limit as described by a greater
percentage than .327

Whereas, the Town of Neshkoro 2016 payable adjusted actual levy is \$125,956; And further whereas
the state law would limit the increase to \$412 (for net new construction) for an allowable town tax levy
of \$126,368 before adjustments, for 2017, collected in 2018.

Now, Therefore the Town Board of the town of Neshkoro, Marquette County does hereby resolve
and order as follows:

1. The town board supports an increase in the town tax levy for 2017 that will exceed the state
levy limit on a continuous basis.
2. The town board directs that the question of increasing the town tax levy for 2017 (to be
collected in 2018) by 31.65 percent, which would increase the town levy by \$40,000 for a total
tax levy of \$166,368 shall be placed on the agenda for the special town meeting to be held
December 6, 2017.
